1985 maintenance donations are now being accepted. Our "ASSETS" figure shown on the bottom line of the Income and Expense Statement below looks and IS impressive but this does not mean that the annual maintenance donations are no longer needed. In fact, they will be needed more than ever during the next five years because we will no longer be able to use the interest from our certificates of deposit for maintenance as we have in the past. If we are to accumulate \$240,000 at the end of five years for perpetual care, we must allow the interest to be compounded.

It is most important that we receive donations to continue maintaining the cemetery for the next five years so PLEASE, do not let us down now. We have come too far and at last, success is in sight.

You might be interested to know that although Glenwood Cemetery has perpetual care, they still assess lot owners \$100 a year plus extra charges if they want special care. Everyone should agree we are getting a good deal just across the fence at Washington Cemetery.
