OUR OLD TREES ARE DYING

If you have visited the cemetery during the past several months, you, no doubt, noticed so many of our trees are dead.

Several of our directors met at the cemetery with a County Agricultural Agent to hear his opinion as to the cause of the problem. We were told it was a combination of three things: the trees' weakened condition from last year's hurricane and tornado and the summer drought, Hypoxilin (the oak tree decline disease) and the granulas spread to kill weeds in the cemetery over a year ago.

We were fortunate to find a man who is cutting down 34 huge trees and hauling away the wood to be sold as firewood for \$3,000. More trees are showing signs of dying and will need to be cut down next year.

The big old oaks were a thing of beauty in W.C. and everyone feels terrible to see this happening.

VANDALISM IN CEMETERY

One night in early Sept. vandals visited W.C. and overturned approximately twenty monuments in the back section next to Glenwood.

Volunteers gathered Sat., Oct. 26th, and with equipment furnished by O. & O. Construction Co., they reset the monuments.

Also, O. & O. Construction people, through the efforts of Sam Belinoski, recently worked three days clearing and leveling the back area so that it can be mowed.

Because of the vandalism, the Board is exploring the possibility of erecting a front gate which will be locked nights.

We are grateful for the responses to our request for donations of burial spaces that family members do not plan to use.

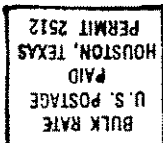
At the present time we are not in a position to take advantage of these offers but hope to be in the future. We shall keep your offers in mind.

MAINTENANCE DONATIONS ARE LAGGING

We do not like to keep harping on the matter of money and hopefully, in four more years this will no longer be necessary. When we organized in 1975 to undertake the tremendous task of restoring and maintaining W.C., we all knew it would not be easy and we were right - it hasn't been.

Since 1978 we have worked diligently together and when we asked, you responded. Your donations cleared the 10-year jungle growth, maintained the cemetery in a respectful condition the past six years, restored the front entrance, cleaned-up the Hurricane "Alicia" mess, and last year raised \$42,000 through the 400+ Club. The bottom line is your donations have worked to make us proud of our accomplishment in our old cemetery and accumulated an amount sufficient to make perpetual care possible in 1990.

As you have heard before, in order to achieve perpetual care, beginning this year we must rely solely on your maintenance donations and can no longer use the bulk of our interest income, which must be reinvested.
