Happy Birthday, CCWCC!

Thursday, January 26, 1995, will mark 20 years since the initial group of 29 concerned citizens met in the home of **Dick and Autrey Ballanfant** to develop a plan to restore and preserve Washington Cemetery.

We haven't made plans for a formal celebration of the event, but hope you will find time to come out the next **Saturday**, **January 28**, and see for yourself just how far we've come in the last 20 years. If the weather cooperates, we'll have our scrapbook there with pictures, so those who weren't here then can appreciate the difference.

Vandals Hit Washington Cemetery

For the first time since we began locking the gate at night, we have suffered serious vandalism. During the first week of August, 116 of our largest monuments were knocked down, probably in the early evening, while the gate was still open. Most were simply toppled and most of these have been set upright again, through the dedicated efforts of Sam Belinoski, Eddie Moy, and Bill Scott. A small number were broken or chipped, and we are still trying to figure out how best to patch them. It will probably require some professional restoration.

A Board committee is looking at several ways to reduce the chances of this happening again, such as changing the hours the cemetery is open, adding lighting, etc. However, as usual, money is a problem. If we want more service than we are getting now, it's going to cost more than the \$2,400 per year we pay now. Further, not even a 24-hour guard (\$110,000 per year!) can guarantee protection from highly motivated punks.

Project PATHH Phase III Progresses

It has now been about 18 months since completion of the major pothole repairs in Phase I and 8 months since completion of the drainage improvements in Phase II. We have been able to observe the results during periods of both drought and deluge, and are now ready to proceed with Phase III, the longawaited asphalt surfacing of all roads.

The specifications for Phase III have been completed and sent out for bids, which are due before Christmas. Weather and scheduling permitting, we expect the work to be completed in the first quarter of 1995.

Although we do not yet have a firm price on the project, we hope that it can be accomplished with the funds presently in hand. Many thanks to all who have contributed to this project over the years. Your generosity and patience will be rewarded.

Clements' Corner

The next time you are feeling rather unimportant, try a little arithmetic. Start with the undebatable fact that it took two people (your parents) to get you here. Each of your parents has two parents, so in the generation prior to your mother and father, there were four people whose pairing off and sharing love contributed to your existence.

You are the product of eight great-grandparents, sixteen great-great-grandparents, thirty-two great-great-grandparents, etc. Keep on multiplying the number by two. If you figure an average of about 25 years per generation, you will discover that when Columbus first set foot on this continent a scant 500 years ago, there were one million, fifty-eight thousand, five hundred and seventy six people on this planet beginning the production of **you**!

Persons who can trace their family ancestry back in a direct line 400-500 years to when surnames began to be required are exceptional; to track all your ancestors is impossible. But unfortunately, many people do not know even their grandparents. It is also true that genealogy is not everyone's cup of tea. However, over the years in talks with individuals and groups, I have often heard these sad comments: "If only I had listened to Aunt Mathilda..." "I was too young and didn't pay attention..." "I wish I had asked Grandma (or Granddad) or Mama about the family ..." Now these relatives are gone, and most often the only link with real people in the past is forever broken.

The cold bare vital statistics (birth, marriage, and death records) and census returns provide only a blank silhouette of a person. To really bring out the colorful details of a person's profile you need the warm facts of size, shape, taste, schooling, religion, political leanings, likes and dislikes, romance, military service, residence, adventures, etc.

To those of you who are older -- *talk* to the younger folks in the family, about all you can remember about yourself, and of those who have gone on before. Or, if you can, jot down some notes to get started and then tell your story to your tape recorder or camcorder. If you don't do it now, who will? You probably have shoeboxes of photographs without pertinent information on the back. Or maybe they *are* marked (sort of). *You* may know what "Susie and me, at camp" means, but thirty years hence, your grandchildren will be baffled. Add some last names, dates, places, ages, etc. Also note whether Susie is a relative or a friend. To those who are younger, don't wait until it's too late. Ask the questions -- do it now -- and do it again and again. Be persistent. Memories need to be jogged, and frequently after a session of remembering the past, other things come to mind -names, humorous events, or things of human interest. Here is an example of a letter CCWCC and its Historian receive every year.

Dear Mr. Clements,

We have been receiving the Washington Cemetery Bulletin addressed to our Grandmother _____. She passed away last year and I have been intending to write to have the mailing discontinued. I would like to make one request. Is it possible to let me know if she was receiving this because of donations made, or do we have relatives buried there? Her maiden name was _____. I would appreciate any help you could give me on this.

Thank you,

The writer of the letter is a very lucky person. Unknown to her at the time she wrote this letter, is that present Washington Cemetery files (and the collecting and storing of information by Mrs. Mistrot and Mrs. Daulley) are a link to the distant past.

It turns out that the writer is a sixth generation descendant of an immigrant couple who came to this country from Germany about 150 years ago. These two people were the writer's great-greatgreat-grandparents. They are buried here, as are her great-great-grandparents, great-grandmother, and other family members.

We are a vital source of information for thousands of people scattered all over the nation (our newsletter is mailed to 35 states.) Write to us -- keep in touch -remember the free, voluntary work CCWCC and WCHT do to maintain this historic cemetery and preserve the links to the past.

Your liberal annual contributions are what keep CCWCC and WCHT healthy and progressively more important as the years go by. We keep the graves clean and green. We can help to do the same with Washington Cemetery family memories.

The net cash flows for the last two fiscal years are somewhat misleading, as they strongly reflect foundation donations to and expenses for Project PATHH, including funds collected for Phase III and not yet paid. For the second consecutive year, *total* member donations failed to offset just the *routine* maintenance and administrative costs.
