## Strangers' Rest Map Taking Shape

Five and a half years after this project began, we can now sometimes predict not only where a marker may be hiding, but also which one. In December, we began a systematic mapping project, starting at the front of Section H. We divided the area into squares about 25 feet on a side, and mapped each square onto a full page, together with names and dates from the record book. Through this process, we are discovering patterns and identifying specific probable grave locations. All eight markers discovered on the last work day were in the first two squares, and six of them were 10 to 12 inches below the surface -- much deeper than most discovered so far. We've found perhaps half of them, but that appears to be the easy half. Please contact Bernice Mistrot if you can help us search and/or record the results.

## **Bequests and Memorials Received**

It is with great sadness that we note the recent passing of several long-time friends of Washington Cemetery. We are, however, most grateful that they and their families chose to honor Washington Cemetery with lasting memorials.

Mary Lorraine Fischer and Naomi Millard Haggard very kindly left generous bequests to CCWCC that will provide for a number of improvements to the cemetery. CCWCC has also received memorial gifts from the friends and relatives of Lt. Col. Rheaford Carl Bell, Carl Patrick Curry, Mary Fischer, Russell Howard Neel, Sr., and Lucille Vordick Smalley, all of which will be added to our Endowment Fund. ## Formal Rules and Regulations Adopted

All cemetery deeds, including those granted by the *Deutsche Gesellschaft* back in 1887, refer to the Rules and Regulations of the cemetery. These have been modified over the years, but have not been enforceable since the Washington Cemetery charter expired in 1947. Now that CCWCC has legal responsibility for the cemetery, we dusted off the old rules and revised them to agree with current state law and standard operating practice for other cemeteries. The new rules may look a bit forbidding due to the necessary legal language, but they are really mostly common-sense things. Here are a few key points:

- All burials (except ashes) require an outer burial container (concrete box), which may be purchased either from the funeral home or from CCWCC.
- Prior to an interment, the plot owner or family member must visit the cemetery to select the burial site and provide written authorization for the burial. Call to arrange interments.
- Headstones, copings, and other monuments must be approved prior to installation. There is a limit of one monument per grave space, but it may be of any style that is similar to those already in the cemetery. Call **Sam Belinoski** for approval.

#### Clements' Corner

#### Lot G-26: Sarah Emma Edmon(d)s(on) Seely(e)

Sarah Emma Evelyn Edmonson, the youngest of five children of Isaac **Edmonson** and his wife Elizabeth **Leeper**, was born in Dec. 1841 in Magaguadavic, New Brunswick, 19 miles southwest of Fredericton.

Unhappy with her father's marriage plans for her, Emma left home by age 16, changed her name to **Edmonds**, and moved to Salisbury (near Moncton, NB), where she trained as a milliner. She may have also worked for a short time in Fredericton and Saint John, NB. Still concerned that her father might find her, she changed her appearance to that of a young man, using the name Franklin **Thompson**, and began selling bibles across New Brunswick and Nova Scotia. The publisher then transferred "Frank" to Hartford, Connecticut and Flint, Michigan.

With the start of the Civil War, she enlisted 14 May 1861 in the 2nd Michigan Infantry Regiment of the Union Army as a male nurse, later becoming a secret agent and dispatch rider. She was active in the battles of Bull Run (First Manasas), Fredericksburg, and Vicksburg. Some of her missions took her behind enemy lines as a spy in disguises including a young Negro man, an Irish peddler woman, a Confederate cavalryman, and a clerk. Her disguises were not revealed until after she left the Army and wrote her 384-page book, *Nurse and Spy in the Union Army: Comprising the Adventures and Experiences of a Woman in Hospitals, Camps, and Battlefields*, in 1864.


On 7 July 1884, President Chester A. Arthur signed a bill, approved by Congress, granting a pension to Mrs. Sarah E. E. **Seelye**, alias Franklin Thompson:

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, that the Secretary of the Interior is hereby authorized and directed to place on the pension roll the name of Sarah E. E. Seelye alias Franklin Thompson, who was a late Private in Company F, Second Regiment of Michigan Infantry Volunteers, at the rate of \$12.00 per month.

Sarah Emma Seelye was mustered into the George B. McClellan Post No. 9 in Houston in 1897, thereby becoming the only woman ever to join the Grand Army of the Republic (GAR), the Union soldiers' veterans organization, though well over a hundred women served in the Union army.

On 27 April 1867, she married Linus Henry **Seely** (1832-1918), a widower, in Cleveland, Ohio. They lived in many states due to his occupation as a carpenter, settling for 12 years on a 10-acre lot known as "Seelye Hill" at Fort Scott, Kansas. In the late 1890s, they were living at La Porte, Texas, where he built a United Church building. It was there that Sarah died on 5 September 1898. Sadly, their three children all died young; two adopted sons, George Frederick and Charles, survived her. After his wife died, Linus Seely returned to his native Saint John, N.B. He died in 1918 at age 85 on Grand Manan Island, off the southern coast of New Brunswick.

On Memorial Day 1901, her body was moved from the La Porte gravesite to its present location in the G.A.R. plot in what was then called German Cemetery. She was reburied with honors, and a special bronze plaque recognized her heroism (the plaque is long gone). Her official military marble headstone reads simply: *Emma E. Seely, Army Nurse*.

Ninety-six years later, Emma was honored once again. On Memorial Day 1997, the Sarah Emma Edmonds Seelye Auxiliary to Sons of Union Veterans of the Civil War held a memorial service at her gravesite. For more information on S.U.V. or the auxiliary please contact Historian **Gov Clements**.

Many interesting articles and stories have been published on Emma's life. In addition to her own best-selling book, she has been the principal character of several other books and a Canadian film is in progress. In 1990, she was inducted into the New Brunswick Women's Hall of Fame in Saint John, NB.

Spelling notes: Linus was born **Seely**, but Emma changed it to **Seelye** soon after their marriage. Upon his return to Canada, he dropped the "e" and his death certificate reads "Linus H. Seely." Similarly, many sources, including Emma's book, give her maiden name as **Edmonds**, but New Brunswick records show that her father's name was **Edmonson**, later spelled **Edmondson**.

## In Memoriam: Carl Patrick Curry

CCWCC lost one of its most dedicated members on Nov. 4, 1997, just two weeks before his 81st birthday. Though Carl had not been active since a stroke three years ago, he was very active with CCWCC for many years, serving 10 years on the Board (1980-1990), including two years as President and two as Vice President. Over the years, he worked hard for legal and legislative solutions for the permanent care of Washington Cemetery, computerized the 1200member mailing list, chaired the Centennial celebration in 1987, and prepared both the index and the detailed list of veterans for the Centennial History Book. A veteran of the D-Day invasion, he was also very active with the 36th Infantry Association. We will miss him, and extend our sincere sympathies to his wife Daria and their children and grandchildren.

## Treasurer's Report (February 1, 1998)

First, we want to thank the 129 donors who have made donations since the start of our 1998 fiscal year. Financially, this has been the best year in our history, largely due to a combination of events that is unlikely to be repeated. Since Oct. 1, we have received nearly \$4,000 in interest deferred from 1997 and over \$40,400 from foundation grants, bequests, and memorials. The unaudited combined financial statement of CCWCC and WCHT follows.

The total value of CCWCC is now about \$492,800, including \$424,100 in the Endowment Fund and \$40,100 in the Improvements Fund. The total value of WCHT is about \$33,400, including \$19,900 in the Improvements Fund and \$7,500 for road repair.

Great progress has been made, but there is still much more to do. The officers and directors collectively spent over 2300 hours last year doing the business of the cemetery, their only compensation being the warm feeling of a job well done.


#### New CCWCC Director, John Petzold
