## CONCERNED CITIZENS FOR CEMETERY CARE

CONCERNED CITIZENS FOR CEMETERY CARE has worked diligently since January of this year to support passage of a bill before the Texas Legislature which would enable cities of over 500,000 population to care for abandoned or unkept cemeteries within their borders.

This bill has been enacted by both houses of the legislature and signed by the Governor as of June 15, 1977.

Our group owes much gratitude to Representative Lauhoff for introducing this bill and to Mr. Willis Hickman and our officers and members for its passage and must now look and work toward urging the city of Houston to take action.

As you may know, the Western Houston Kiwanis Club and its affiliates have been working and cleaning in the cemetery for over a year and one-half, and the next dates set for their working there are July 16th, now past, and on August 20th, beginning about 9:00 A. M. May we ask you to come out and help?

At the last meeting on June 26th of the Concerned Citizens, the group voted to become a non-profit corporation and chose a name and elected a board of directors.

The name for our new group, under a state charter, will be one of the following:

- a. Citizens for Washington Cemetery Care
- b. Concerned Citizens for Washington Cemetery Care
- c. Washington Cemetery Society

It is necessary to submit three names to the Secretary of the State of Texas, as there might be a duplicate name in use womewhere in the state.
