The Historical Society furnished invitations to persons living in or near Houston who have made contributions; however, everyone is invited and welcome to attend. We will not be able to furnish chairs so please remember to bring your law chair. Cookies and punch will be served and we need lots of cookies! Ladies willing to furnish a batch of cookies please call Lois King, 682-3375, or Mildred Daly, 668-8689. Flowers on the graves would make the cemetery even more beautiful on this great occasion. You might want to place flowers on graves of your loved ones this day. Young people from Children of the Confederacy will be on hand to direct traffic and to help carry and set up chairs. Parking in the cemetery is limited so we ask all "good walkers" to park in the Post Office parking lot adjoining the cemetery. An interesting and entertaining program is planned. Please plan to attend.

Attorney Charles Saunders with Fulbright & Jaworski has agreed to help us with our legal matters. We are grateful to Mr. Saunders for his willingness to work with us and hope we are at long last making progress in this direction.

Letters were sent to twelve corporations asking if they would be willing to donate the cost of our historical marker. Checks were received from Brown & Root, Houston Natural Gas and Southwestern Bell, each for \$475. Houston Nat. Gas and Southwestern Bell agreed to donate their checks to our Special Fund since Brown & Root was the first to respond. Earlier this year we received a check for \$200 from Bortunco Foundation.



Mr. Noland has installed a telephone answering machine at the cemetery house to eliminate communication problems.

Due to rain two consecutive Saturdays after a scheduled cutting, our man was unable to work in the cemetery. The grass was cut Sept. 20 and looked beautiful but two or three weeks prior to that time it was another story. He always works for us Saturdays when a large crew is available to him.

AND NOW, A SERIOUS MATTER! Last year 945 people contributed \$22,796 as compared to 530 people, \$13,851 this year. We have lost contact with some members due to changes of address and some have passed away but we suspect some have become apathetic now that the cemetery is being cared for or think we do not need the money since we were so fortunate to have received \$21,646 for our Special Fund, not realizing this money can be used only to earn interest for maintenance.

To insure perpetual care, a goal of \$200,000 is needed to earn enough interest to cover our costs each year. Last year we had a surplus of \$10,000 over and above expenses to add to our Special Fund. As shown by the figures above, this year we will not have any surplus.
