CHANGE IN IRS CODE NOT LIKELY

We have been advised that it is unlikely we could qualify for IRS code 501(c)(3); thus, we cannot obtain contributions or matching gifts from most major corporations, including our good friends at Exxon.

MAINTENANCE DONATIONS NEEDED!

As you know, your officers and directors have always been completely open regarding the finances of our organization. Since July 1981, our newsletters have itemized income, expenses, and total assets. So once again, we "lay our cards on the table" to you, our members.

At our recent meeting, our Treasurer again described a financial problem that has become increasingly worse over the past three years. Very simply, **OUR MAINTENANCE AND OPERATING EXPENSES HAVE BEEN EXCEEDING OUR MAINTENANCE DONATIONS.** The following figures speak for themselves (calendar year totals.)

So far, the Maintenance fund has been able to absorb the deficit, however, if it continues, we will be forced to use interest from money invested in the Perpetual Care fund. If this happens now, we may never realize an ADEQUATE Perpetual Care fund.

To ensure sufficient money in the Maintenance fund to cover operating expenses, the Board has adopted the following policy:

1. First \$36 of each individual's donation in any fiscal year goes for Maintenance.
2. Bequests will be used for the purpose specified. If not specified, they will normally go to the Perpetual Care fund.
3. Donations from organizations will be used for the fund marked, or if not marked, for the fund most in need at the time.
4. Donations for which no fund is specified will be used for the fund most in need.
5. All interest on CD's goes into the Perpetual Care fund. Interest on the checking account and MMA is used for Maintenance.

There is some good news: the Perpetual Care fund has grown from \$158,758 in June 1986 to \$265,793 in Mar. 1989. Looking at this figure, members may tend to feel donations are no longer needed, but such is not the case. This amount is only half what we presently believe we would need to actually meet all expenses from interest alone, and cannot be spent, now or in the future.

We continue to need your support, and that of **younger members of your family**, to cover the everyday expenses of grass cutting, printing, postage, and minor operating expenses. It takes nearly 34 donations of \$36 to pay for just one grass cutting. We thank those who have already sent their 1989 donation, and we urge those who haven't to do so now.
