Dear Concerned Citizen for Washington Cemetery Care:

Our organization will meet next Sunday, October 1, at 2:30 p.m. at the First Evangelical Church, Holman and Caroline, across the street from San Jacinto High School. Parking will present no problem. You may park on the high school parking lot (in front of the church), on the Austin Street side of the church or behind the church.


