EXXON WILL NO LONGER MATCH OUR GIFTS

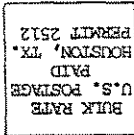
As they say, all good things come to an end, and so it is with Exxon's matching gifts to Washington Cemetery. We have recently been informed that they will no longer match donations made to CCWCC by Exxon employees and annuitants.

The difficulty is that we qualify for tax-exempt status for donors under IRS section 501(c)(13), however, Exxon will match gifts only to organizations qualifying under IRS section 501(c)(3). The CCWCC Board is trying to see what can be done to allow CCWCC to qualify under section 501(c)(3). We are thankful for the generous donations we have received from Exxon since 1981.

ADDITIONAL BURIAL RECORDS DISCOVERED

Careful examination of the microfilm in our safe deposit box has revealed the existence of numerous W.C. burial records prior to 1900 which had previously been thought to be lost.

Considerable research needs to be done to "match up" the records in the three burial books with each other and with tombstone inscriptions. This is a major undertaking, and will probably take several years to complete. As a first step, we need to make a paper copy of the microfilm, plus a back-up copy of the film, in order to safeguard the original. These copies will cost about \$500.

Your directors do not feel this money should be spent from our maintenance or perpetual care funds, therefore, we are asking for donations from members who are particularly interested in the history of our cemetery.
