TREASURER'S REPORT

The maintenance fund still needs your help. Maintenance donations were more this year than last year, but still less than our expenses. Our perpetual care fund grew by 10% last year—mostly due to interest. This added principal will provide more income to maintain the cemetery in the future, but will not help us right now.

Donations for fiscal 1990 are now being accepted. Please remember that the first \$36 must go for maintenance; if you can be more generous, we always appreciate it. We have also established a fund for improving the roads, but as always, we will not start the work until we have the money to pay for it.
