ROAD IMPROVEMENT PLANNED

All will agree that the roads in Washington Cemetery are in terrible condition and it's time to do something about them. We have filled in the holes with crushed stone four times since taking over maintenance of the cemetery, but that has not been the answer. Any improvement lasted only until the next heavy rainstorm.

The Board is now obtaining bids for repair of the holes and low spots and new asphalt topping of all the roads. This project will be costly, but will give us roadways we can be proud of for many years to come.

At this time, it has not been determined what the cost will be; however, the Board promises to get the best road possible for a reasonable amount of money. We now have \$4500 in the Special Projects fund, most of which will go towards the cost of the roads, but much more will be needed.

With income tax time upon us, this is a poor time to ask for money, but if not now, maybe later after you recover, you will want to send an extra donation to the Road Improvement Fund. We urge everyone to support this project - whatever amount you feel you can afford.
